Failure to obtain the written Certificate of Release from the MLCC is a violation of the rules and regulations of MLCC.

Sellers of Alcohol **may not** ship alcohol or alcoholic beverages to the BUYER until they receive the copy of the executed Certificate of Release. The MLCC will return a copy of the Certificate of Release to the BUYER and to the SELLER of Alcohol. A copy of the Certificate of Release **MUST** be sent with the shipment.

I certify that the information contained in this form is true and accurate to the best of my knowledge and belief. I agree to comply with all requirements of the Michigan Liquor Control Code and Administrative Rules. I also understand that providing **false** or **fraudulent** information is a violation of the Liquor Control Code pursuant to MCL 436.2003.
